January Programming Meeting Recap

On Saturday January 11th from 9:30 a.m. to 12:00 noon the annual Legislative Panel event was held at the Girl Scouts of Utah building. Around 80 guests including many AAUW members from both the Salt Lake City and Wasatch branches, League of Women Voter members, and the general public filled the conference room to hear a distinguished panel of Utah lawmakers. The panelists included: Becky Edwards (R) House District 20

event was co-sponsored by the
League of Women Voters and
both AAUW Salt Lake City and
Wasatch Branches.



This year the panel moderator was Sharon Walkington from the League of Women Voters with Eva Marie Bates, President of the Wasatch Branch, acting as time keeper. These women had to be at the top of their game as they worked carefully to bring order to the event and ensure that the panelists had ample time to cover as many of the audience members concerns in the form of questions possible, in the allotted time.

Questions posed to the panelists ranged from air quality to taxes and everything in between. All the panelists did their best to answer all questions in a genuinely forthright way and were willing to state when an area was not in their area of expertise or focus. Some highlights included Becky Edwards drawing on her background of representing the North Salt Lake air quality concerns and giving insight into her work to improve air quality which she believes among other things will require a commitment from Utah residents that may include lifestyle changes especially related to transportation. Karen Mayne was captivatingly dynamic as she discussed her concern when she saw detailed Utah voter information posted online. This is a result of the fact that anyone can purchase this information from the lieutenant governor's office without any real government oversight on how the information will be used. Karen has real concerns about identity theft and invasion of privacy and is sponsoring legislation that would limit access to the Utah voter registration database. Marie Poulson made a point to give insightful answers to all questions related to her passion of supporting Utah schools since she has been an active public educator since 1971. She has been working to sponsor and pass education legislation that provides for the accounting of class size, supports Utah



educators and encourages broad-based curriculum. Howard Stephenson came directly to the panel event from a radio show he hosts called, Red Meat Radio (860 AM Utah's Big Talker), every Saturday morning from 8 to 10 am. Along with his insights into all questions related to his work in the senate since his first election win in 1992, he stressed the importance of

Utah citizens understanding the way their tax money is being spent. He brought with him a 2013 Fast Tax Summary and easy reference booklet and referred to it whenever fiscal responsibility questions were brought up related to major Utah state and local taxes.

At the end of the Legislative Panel event the excitement in the room was evident and it became apparent that audience members enjoyed their opportunity to ask questions about issues that were important to them. It was clear that this is a highly popular event and that the hard work of the League of Women Voters, AAUW Salt Lake and Wasatch Branches was well worth all the effort.

\$tart \$mart Update

We are very excited to let you know that Utah's first \$tart \$mart\$ Workshop will be held on February 24, 4:30-8:00 pm, at the University of Utah's Union. Interested students should contact Ann House (801) 585-7379 to register. The interactive workshop is scheduled this year as part of U Saves Week sponsored by the Associated Students of the University of Utah (ASUU). \$tart \$mart\$ is a joint project of AAUW and the WAGE Project. It is designed to provide college women with the knowledge and skills needed to negotiate fair and realistic compensation.

Over the past few months Sally Hoffelmeyer-Katz from the Wasatch Branch and Claire Turner from the Salt Lake City Branch have met with Ann House, Coordinator of the ASUU's

Personal Money Management Center, and Debra Daniels, Director of the Women's Resource Center, to finalize arrangements for holding *\$tart \$mart* at the U of U. Dorrie Sieburg, Wage Project *\$tart \$mart* Program Manager, has provided logistical support from the national Wage Project office. Having been trained and certified by the Wage Project, Sally will facilitate the February 24th workshop. This initial *\$mart \$tart* workshop is being funded by the state office of AAUW.



Vagina Monologues, February 8, 7:30 pm, Westminster College (Emma Eccles Jones Conservatory in the Vieve Gore Concert Hall)



What this is about: The *Vagina Monologues*, written by Eve Ensler, was originally an off Broadway play. Each monologue focuses on an aspect of feminine experience and sexuality. Eve Ensler gathered material for the play by interviewing 200 women about their own views on sex, relationships, and violence against women. The play is both thought-provoking and hilarious.

Why you should attend: The play benefits V-Day, a global non-profit movement that supports women's anti-violence groups. The Westminster performances will specifically benefit the Rape Recovery Center in Salt Lake City. After the play,

our group and other audience members can take part in a short "talk back" with the actors. The monologues are performed by Westminster alumni, students, staff, and community members.

President's Message



Happy New Year AAUW SLC Branch Members! Since a start of a new year is the traditional time to think about resolutions I have decided that it is most appropriate to put at the top of my 2014 resolution list thanking as often as possible all the amazing AAUW members who give of their time and talent to make our branch events powerful community happenings. On December 21st our branch held the annual Red Candle Tea where a large number of our members bravely ventured out in the Utah white winter

wonderland weather to come together and not only socialize but support our important organizations vision and mission: "AAUW Empowering Women Since 1881" and "Advancing equity for women and girls through advocacy, education, philanthropy, and research."

First, at the Red Candle Tea event we all witnessed firsthand this advocacy work in action as the women in attendance brought with them 47 books, and another 7 games, puzzles and learning activity kits to be donated to the South Valley Sanctuary to be used in The Children's Learning Center. The South Valley Sanctuary provides a 24 hour, 365 day facility for victims of domestic violence. Since young children are often a part of these families in crisis having a special learning space for them with quality books and learning materials is vital. Victims, most often women and children, can obtain housing and counseling services for up to 30 days so a learning space for the children to have a place to both play and learn was greatly needed. Staff at the Sanctuary will also use these donated items to train and further their knowledge regarding trauma in children and families as they aim to embrace and provide a trauma informed center. The center staff supports positive communication and cooperation with parents and children in the

learning space as a way to provide a healthy, safe environment for them to positively re-connect.

Second, at the Red Candle Tea event all in attendance were thrilled by a Rock-Scissors-Paper game where members joined in for a dollar or five dollar donation. Our magnificent board Corresponding Secretary Carole Rusho turned out to be the last player standing and found herself holding over a hundred dollars in donation money that was quickly turned over to Martha Bale the board Legal Advocacy Fund Chair. While



this was all done in the spirit of fun it was a marvel to watch as once again at this same event the SLC Branch members reached into their pockets to support the Legal Advocacy Fund (LAF). As reported in the 2013 AAUW Annual Report titled Building a Better Future for Women and Girls, the LAF supported more than 50 plaintiffs in 2013 in nine gender equity cases. Nine Case Support Travel Grants were also given which allowed LAF supported plaintiffs to travel to AAUW state conventions across the country to speak about their experiences. Fifteen LAF campus Outreach Grant

projects helped branch members and campus teams to collaborate to education college students about Title IX, sexual assault prevention, fair pay and women in leadership. It is powerful to think how the philanthropy of SLC Branch members through a simple child's game will be used to legally protect women and girls in 2014.

The Red Candle Tea was a wonderful success because of SLC Branch members and their willingness to not only attend branch events but to actively engage to positively support women and girls having a better future. I will now put one big check on the top item of my 2014 New Year Resolutions list with this simple but very public whole-hearted statement "Thank You AAUW SLC Branch members, you are simply the
